## **Our Policies**

We provide training to our employees to ensure they understand the risks of modern slavery and human trafficking and can identify and report any concerns. Training is conducted annually and includes the following: Identifying Modern Slavery: Recognizing signs of modern slavery and human trafficking.

Reporting Mechanisms: Procedures for reporting suspected cases of modern slavery within our operations and supply chains.

Supplier Engagement: Educating suppliers about our policies and expectations regarding modern slavery and human trafficking.
